1. The school contact person must be over the age of 18.

The Promoter reserves the right, at any time, to verify the validity of entries and entrants and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
5. Boxes containing other objects or materials that are not listed as suitable items on appendix below will be deemed invalid.
6. The prizes are not transferable or exchangeable and cannot be taken as cash, unless stated otherwise.
7. If a competition is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel a competition, as appropriate.

9. The Promoter reserves the right to approve or reject any or all entries at their discretion.
10. Each entrant agrees that the Promoter may publish the school's name on relevant and applicable platforms including social media platforms.
11. The Promoter and its associated agencies and companies shall not be liable for any loss (including, without limitation, indirect or consequential loss), expenses, damage, personal injury or death which is suffered or sustained (including but not limited to that arising from any person's negligence) in connection with an entrants competition entry and/or the use of any prize, except any liability that cannot be excluded by law (in which case that liability is limited to the minimum allowable by law.) Each entrant shall indemnify the Promoter (and their respective directors, officers, employees and agents – each an "indemnified person") for any loss, liability, cost, damage or expense suffered or incurred by any indemnified person as a result of (i) the entrant breaching any of these Terms and Conditions; (ii) a warranty given by the entrant providing to be untrue; and (iii) any personal injury arising from or related to any wrongful or negligent act or omission by the entrant in connection with a competition. The entrant's liability under the indemnity in the clause is reduced proportionately to the extent that the liability is caused or contributed to by the wrongful or negligent act or omission of any indemnified person.
